- E) Invite experts from various fields to give lectures and conduct seminars either for students or for the faculty or for public.
- F) Depute faculty or administrative staffs or any other staffs on training or on any other work to any place in India and likewise to send students or research scholars to go on training anywhere in India.

Further, vide the same notice dated 04.05.2024 the Settlor has intended to renounce/extinguish all authorities that she has over the functioning of the Trust which is provided under the Principle Trust Deed. The said intension of the Settlor came to be admitted by the Incoming Trustees and accordingly resolved to amend the provisions of the Principle Trust Deed so as to exclude all authorities of the Settlor in the Principle Trust Deed.


